Investment Philosophy

A clearly defined investment philosophy can help explain how decisions are made.

Alignment between the sponsor and investors is a critical factor.

- Sponsor co-investment in the deal
- Fee structure and incentives
- Participation in both upside and downside outcomes

When a sponsor has meaningful capital invested alongside investors, it can reinforce alignment around long-term performance rather than short-term outcomes.

Approach to Risk Management

Every investment involves risk, but how that risk is managed can vary significantly.

Areas to evaluate include:

- Use of leverage and debt structure
- Complexity of the business plan
- Exposure to market timing or exit assumptions

Sponsors who prioritize stability and downside protection may produce more consistent outcomes, even if projected returns appear more moderate.

Execution Capability

A well-structured investment still requires effective execution.

This includes:

- Operational oversight
- Asset management
- Decision-making throughout the hold period
